TERMS AND CONDITIONS OF SALE

Bidders will be required to attach to their bids copies of Omang/identity documents as proof of citizenship, while Companies will be required to attach Certificates of Incorporation, and identity documents of Shareholders as a proof of ownership.

The reserve price for the vehicle is BWP60, 695.00 and this is the minimum possible price, therefore bids below this price shall not be accepted.

No individual nor company may bid on behalf of another.

Bidders should bid for the vehicle through a bid form. The completed bid form should then be placed in a plain envelope labelled 'VEHICLE B 412 AZD SEALED BID'. The envelope must not bear any indication whatsoever of the name of the bidder.

The bids should be deposited in the 'tender box' located at the Botswana Tourism Organisation (BTO) Reception, Head Office 1st Floor, no later than 1400hrs, on the 2nd February, 2024.

Late bids shall not be accepted. Telephone, hand delivery, telegraphic, fax or email submissions shall also not be accepted. The opening of the bids shall be done shortly after closing of bids at the BTO Head office in the presence of bidders.

The Vehicle shall be sold as is - "Voetstoots", without warranties or guarantees.

The successful bidder will be allowed a maximum period of four (4) working days from auction date to have fully paid and collected the vehicle from the BTO premises.




